제외). Two valid identifications and SIN are required as following (at least ONE should be a Primary ID). Ontario Health Card is NOT acceptable.

*Primary Identifications (Photo ID):

- 1. Provincial or Territorial Driver's License
- 2. Passport
- 3. Permanent Resident Card
- 4. Provincial or Territorial Identification card (MUST bear Photograph and Signature)

*Secondary Identifications:

- 1. Credit Card / Debit Card
- 2. Certificate of Canadian Citizenship OR Certification of Naturalization
- 3. Birth Certificate
